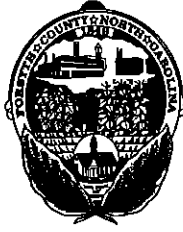

Re: September 25, 2013 email correspondence

Dear Ms. Myrick:

Thank you for your email of September 25, 2013 concerning the Forsyth County Board of Elections response to your public records request of September 11, 2013. I do not understand your concern over the number of cards that were sent to you. In your request you asked for "all" voter registration verification mailings held at the WSSU post office. The Director of the Board of Elections sent you "all" voter registration verification mailings that were returned from the WSSU Post Office. Your use of the word "all" was reasonably interpreted to mean everything, and in that regard "all" held at the WSSU post office were sent to you at no charge. The Director correctly did not rely on any count that may have been erroneously reported in a newspaper.

Any labels/stickers, with an explanation as to why the mailings could not be delivered, if any there be, would appear on the cards previously sent to you. Should you entertain thoughts to the contrary, then you are at liberty to come and inspect these documents. If you are inclined to come and inspect these records/documents, I would ask that you arrange to do that during a mutually convenient time upon reasonable notice please.

The personal, private, email addresses of the members of the Forsyth County Board of Elections are not public record within the meaning of N.C. Gen. Stat. §132-1. In that regard I am unable to provide you with private personal email addresses. However, you may contact them through the Director as I am certain he will share all your correspondence with them. I believe you have Mr. Coffman's email address and if you do not, I should be glad to provide it.

I would like to point out that the Forsyth County Board of Elections has no control over how the post office as WSSU conducts their business. There is no document, to my knowledge, to commemorate any
